ICP DAS CO., LTD. is taking and will take due diligence within our supply chain to assure "DRC Conflict-Free" for the Minerals of gold (Au), tantalum (Ta), tungsten (W), cobalt(Co) and tin (Sn) are not derived from or sourced from mines in conflict areas of the Democratic Republic of Congo (DRC), or illegally taxed on trade routes, either of which are controlled by non-governmental military groups, or unlawful military factions. Trade routes not confirmed to be "Conflict Free" include direct exports from the DRC, as well as exports through Rwanda, Uganda, Burundi, Tanzania and Kenya (countries of whom the U.N. Security Council note are global export routes for DRC-mined minerals).

ICP DAS CO., LTD. would like to confirm Minerals used in Products sold to CompuwareTechnology Inc. are "DRC Conflict-Free".

ICP DAS CO., LTD. hereby formulated this Conflict Minerals Policy and makes following commitments:

- Request its suppliers to refuse to use Conflict Minerals from the Conflict Regions and present a signed letter of commitment to ICP DAS CO., LTD..
- Request its suppliers to notify their upstream/downstream suppliers to follow Minerals Conflict-Free requirements.
- 4. Continuing our industry leadership and our efforts to source conflict-free minerals from the DRC where possible.
